EU residence permit information in LATVIA

This is a brief overview of the qualification criteria for obtaining EU residency in Latvia. When acquiring an apartment at **Riga Waterfront**, you will be referred to a partner legal office that will assist you throughout all residency application procedures.

1. Main bullet points - requirements for Temporary Residence Permit (TRP) via real-estate investment

- Property must be non-agricultural, non-forest real estate in Latvia. (residencies.io)
- Investment threshold: if cadastral value is insufficient, a certified appraiser's report showing market value ≥ €250,000 is required. (residencies.io)
- Pay **5** % of the real estate purchase value into the state budget at the time of the first TRP application. (pmlp.go)
- Real estate must be purchased from a legal seller (legal entity or individual satisfying legal conditions) and transaction by non-cash payment. (*residencies.io*)
- Health insurance, clean criminal record, proof of funds, other standard TRP requirements. (residencies.io)
- The TRP is (in many cases) granted for up to 5 years. (pmlp.gov.lv)

2. Stay / physical presence requirement: how many days, how often per year?

- For temporary residence permit (via investment): there is no strict minimum number of days you must stay in Latvia annually to *maintain* the permit; but you must visit at least once per year (for registration or re-registration). (Immigrant Invest)
- For **permanent residence permit**, some sources indicate more stringent presence: e.g. "reside in the country for four years out of the five-year period" or **183 days per year** on average over the period. (*Henley & Partners*)
- Another cited rule: you cannot be absent from Latvia for more than six consecutive months,
 or more than one year in total over the 5-year period when applying for permanent
 residence. (IT CAMP)

3. Renewal of TRP: yearly or every five years?

- The TRP is often granted for up to five years in the investment (real estate) route. (pmlp.gov.lv)
- However, the residence permit card (the physical ID card) must be renewed annually (i.e. the
 card is re-registered / renewed every year) even if the permit itself is valid for a 5-year term.
 (estatelatvia.com)
- After the 5-year period, you may renew the temporary permit (if conditions still met) or apply for permanent residence. (investinlatvia.org)

4. Tax obligations: do TRP holders become Latvian taxpayers or need tax declarations?

- Holding a temporary residence permit does not automatically make someone a tax resident of Latvia. (artHauss)
- Whether a person becomes a tax resident depends on other criteria (duration of stay, center of
 vital interests, etc.) under Latvian tax law. (Sources imply you are not required to become
 taxpayer just because of permit). (artHauss)
- However, if you derive income in Latvia (e.g. rent, business) you may have to file tax returns in Latvia for that Latvian-source income. (This is general principle in many jurisdictions; you should check Latvian tax law).
